Recovery & Rehabilitation Program- The objective is to help men & women that are homeless and addicted by providing safe housing & spiritual support. This helps them become productive members of society. In 2020 we separated the locations into new 501(c)3 organizations. Warriors Center USA provided oversight to each organization in the Recovery & Rehabilitation Program. In 2022 we housed 299 men & women that were homeless. The average stay is 120 days. The average counseling & group hours per individual is 292 hours of rehabilitation treatment. We served 214,620 meals to those in the Program over the year. We helped provide healthcare for 121 men & 81 women through local medical partnerships. We provide dental care through community dental for men and women. We provided clothing for 178 men and 90 women. We trained 173 men and 79 women with work therapy to help them learn a balanced life, learn to work in the workforce, and build trade skills for the future. 50 men and 30 women graduated from the Programs. Our program provides a stage for community outreach work to help the homeless community. We did 186 homeless/community service outreach events to nursing homes, inner city food pantries, home improvement projects for individuals & families, children’s hospitals, and Memphis area homeless camps & bridges.
